The Dispute Resolution Forum of IBA in Islamabad Hosted first public seminar on commercial, corporate and regulatory mediation at NIBAF, Islamabad

The event was attended by guests and participants from SECP, CLDP, FBR, PSX, Federal judicial academy, State bank of Pakistan, Jazz, Zong, Pakistan bar council, Ministry of Law, Leading legal colleges, and Private legal practitioners.

The welcome address was given by Director CEE, Kamran Bilgrami.

Zmarak khan, Senior Counsel at the Commercial Law Development Program (CLDP) at the United States Department of Commerce shared insights on his vision for the collaboration of CLDP with Pakistan and mainly with the Dispute Resolution Forum, IBA in which he mentioned the importance of collaboration and partnership and how these partnerships can strengthen the legal landscape of Pakistan.

Hon'ble Justice Jawad Hassan, Judge at the Lahore High Court addressed the gathering in the Keynote speech and highlighted the significance of mediation, emphasizing its role in "sharing the burden of judicial matters and resolving disputes amicably."
