## INTRODUCTION

Supply chains are the arteries of today's globalized economy and thus managing Global Sourcing in these supply chains has never been as challenging as it is today. As more companies have outsourced production to overseas locations, supply chains have been extended, the number of nodes increased, and the complexity of the networks has grown exponentially. This workshop is especially designed to develop Operational, Tactical, as well as Strategic level knowledge of "Global Sourcing". It will expose the participants to the best practices, drivers, barriers, models, tools, financing and payment methods, and stakeholders (such as importers, exporters, banks, customs, freight forwarders and NVOCCs) involved in global sourcing.

This workshop will not only focus on abstract global sourcing but will also enable the participants to learn it by experience via "Gamification" – i.e., advanced simulations that are more than theory and are proven effective pedagogical tool. This applicative nature of the workshop provides an opportunity for companies and individuals interested in developing effective global sourcing skills to aim for "Sourcing Leadership". Trainers will present practical advice and guidance underpinned by academic theory and supported by an extensive range of real-world case studies including famous companies in Pakistan. Participants are shown how to develop, deliver and sustain Global sourcing performance with clear and accessible guidance. Another advantage is the exposure to content backed by globally renowned sourcing bodies (such as CIPS, UK and ISM USA).

- Approaches: Kraljic Matrix; TCO /TCA /TLC Calculations, Models and Matrices; Spend Analysis; Reverse Auction; Foreign Supplier's Quality Assurance; Performance Measurement of Import Process. [apply, analyze & evaluate]
